Terms of the proficiency test (PT)

DLA 17/2017 - ALM-Verification Gluten: 5 Samples containing Wheat Flour in Maize-Chips-Matrix (levels: 2,0 / 10 / 20 / 50 / 100 mg/kg)

Test material*:

For the Action Level Matrix Verification Test (ALM) a set of **5 samples with specified contents of gluten** from wheat flour as well as a "blank sample" are provided for determination in the **matrix** of **maize chips.** The gluten level of the middle sample (appr. 20 mg/kg) corresponds to the Action Level 1 (VITAL concept 2.0) and judgement value of the German Commission ALTS/ALS, respectively. The 6 PT samples are blind-encoded, so that the gluten contents are not recognizable by the sample labeling.

Sample weight: 6 samples 20 g each.

* Note: Control of mixture homogeneity and qualitative testings are carried out by DLA. Testing of the content, homogeneity and stability of PT parameters is subcontracted by DLA.

Methods + realisation time:

Analytical methods for qualitative and quantitative determinations are optional.

There is a 6 weeks period for performing the analysis. The results are transmitted by e-mail via the provided results file.

Evaluation report:

The evaluation of PT-results is carried out qualitatively (positive/negative) in scores of 1-5 (for example score 3 = Action Level successfully identified). Quantitative results will be reported for information. Results, limits of detection and/or quantification and remarks to the methods will be documented. DLA intends to finish the evaluation report within 6 weeks after deadline of results submission. Each participant receives an anonymized, complete evaluation report as a PDF-file, identifying the own results by individual code in case payment was done. A print-out can be sent on demand.

Registration:

The reliable order can be sent to DLA or our authorized sales partner.

Shipment + number of participants:

Required minimum number of participants is 10. The samples will be sent to participants in the **week**13 by package service with tracking (delivery time 2-3 days within Europe, 2-5 days worldwide).

Deadline of result submission:

Last date for submission of results 12th May 2017.

Invoice + price :

Invoicing will be done by DLA along with the sample shipment or by our authorized partner in parallel to the sample shipment.

The price of the proficiency test is 295,-- € per participant plus shipping and possible tax.
