# DLA 49/2017 - Cosmetic Products II: Caffeine in Hair Shampoo

### Test material\*:

There are **two identical samples** with the parameter **Caffeine** to be determined. The **matrix** is **hair shampoo**.

Sample weight: 2 Samples 25 g each.

\* Note: Control of mixture homogeneity and qualitative testings are carried out by DLA. Testing of the content, homogeneity and stability of PT parameters is subcontracted by DLA.

### **Methods + realisation time:**

Analytical methods for quantitative determinations are optional.

There is a 6 weeks period for performing the analysis. The results are transmitted by e-mail via the provided results file.

### **Evaluation report:**

The **evaluation** is carried out from a total of 7 results on **quantitatively**. It includes kernel density estimation, outlier tests, robust mean, robust standard deviation and z-scores. The assigned value is the robust mean of participants results. Results, limits of detection and/or quantification and remarks to the methods will be documented. DLA intends to finish the evaluation report within 6 weeks after deadline of results submission.

Each participant receives an anonymized, complete evaluation report as a PDF-file, identifying the own results by individual code in case payment was done. A print-out can be sent on demand.

## **Registration:**

### **Shipment + number of participants:**

Last date for submission of results **06**<sup>th</sup> **October 2017**.
