Terms of the proficiency test (PT)

DLA 49/2018 – Heavy Metals and Trace Elements in Food, approx. 20 Elements

Test material* :

There are two identical samples with the parameters AI, Ba, Ca, Cd, Co, Cr, Cu, Fe, I, K, Mg, Mn, Mo, Na, Ni, P, Rb, Se, and Zn with possibly low contents to be determined. The matrix is Food (skimmed milk product).

Sample weight: 2 Samples 8 g each.

* <u>Note:</u> Control of mixture homogeneity and qualitative testings are carried out by DLA. Testing of the content, homogeneity and stability of PT parameters is subcontracted by DLA.

Methods + realisation time:

Analytical methods for quantitative determinations are optional.

There is a 6 weeks period for performing the analysis. The results are transmitted by e-mail via the provided results file.

Evaluation report:

The **evaluation** is carried out from a total of 7 results on **quantitatively**. It includes kernel density estimation, outlier tests, robust mean, robust standard deviation and z-scores. The assigned value is the robust mean of participants results. Results, limits of detection and/or quantification and remarks to the methods will be documented. DLA intends to finish the evaluation report within 6 weeks after deadline of results submission.

Each participant receives an anonymized, complete evaluation report as a PDF-file, identifying the own results by individual code in case payment was done. A print-out can be sent on demand.

Registration :

The reliable order can be sent to DLA or our authorized sales partner.

Shipment + number of participants:

Required minimum number of participants is 10. The samples will be sent to participants in the **week 17** by parcel service with tracking (delivery time 2-3 days within Europe, 2-5 days worldwide).

Deadline of result submission:

Last date for submission of results **08th June 2018**.

Invoice + price :

Invoicing will be done by DLA along with the sample shipment or by our authorized partner in parallel to the sample shipment.

The price of the proficiency test is $370, -- \in$ per participant plus shipping and possible tax.
