Terms of the proficiency test (PT)

DLA ptALM2 - ALM-Verification Sesame: 5 Samples containing white Sesame in Spice Cracker Matrix (levels: 1,0 / 5,0 / 10 / 25 / 50 mg/kg), Allergenic Material: Mixture of at least 4 Sesame Varieties

Test material*:

For the Action Level Matrix Verification Test (ALM) a set of **5 samples with specified contents of sesame** as well as a "blank sample" are provided for determination in the **matrix** of **spice crackers**. The allergenic ingredient (mixture of at least **4 varieties of sesame**) was baked within the matrix. The sesame level of the middle sample (appr. 10 mg/kg) corresponds to the Action Level 1 (VITAL concept 2.0) and judgement value of the German Commission ALTS/ALS, respectively. The 6 PT samples are blind-encoded, so that the sesame contents are not recognizable by the sample labeling.

Sample weight: 6 samples 20 g each.

* Note: Control of mixture homogeneity and qualitative testings are carried out by DLA. Any testing of the content, homogeneity and stability of PT parameters is subcontracted by DLA.

Methods + realisation time:

Analytical methods for qualitative and quantitative determinations are optional.

There is a 6 weeks period for performing the analysis. The results are transmitted by e-mail via the provided results file.

Evaluation report:

The **evaluation** of PT-results is carried out **qualitatively** (positive/negative) in scores of 1-5 (for example score 3 = Action Level successfully identified). **Quantitative results** will be reported for information by its recovery rates. From 5 quantitative results one level will be evaluated by **z-scores** for information. DLA intends to finish the evaluation report within 6 weeks after deadline of results submission.

Each participant receives an anonymized, complete evaluation report as a PDF-file, identifying the own results by individual code in case payment was done and can object in writing to the evaluation within 6 weeks.

Registration:

Shipment + number of participants:

Required minimum number of participants is 10. The samples will be sent to participants in the **week 18** by package service with tracking (delivery time 2-5 days within Europe, 2-10 days worldwide).

Deadline of result submission:

Last date for submission of results 12th June 2020.

Invoice + price :

Invoicing will be done by DLA along with the sample shipment or by our authorized partner in parallel to the sample shipment.

The price of the proficiency test is 324,-- € per participant plus shipping and possible tax.

Costs for double sample material € 85,00.
