# DLA ptASW1 (2020) – Allergen Swab Test I: Gluten, Peanut, Sesame and Soya

(2 Test Surfaces per Allergen, qualitative)

## Test material\*:

There are **8 test areas** possibly containing the allergenic **parameters Gluten**, **Peanut**, **Sesame** and **Soya** for qualitative determination. 2 areas are to be tested per allergen (one them is positive). The amounts are in the range of 10 - 100  $\mu$ g/test surface.

Sample number: 8 test surfaces of approx. 30 cm<sup>2</sup>.

\* Note: Control of mixture homogeneity and qualitative testings are carried out by DLA. Any testing of the content, homogeneity and stability of PT parameters is subcontracted by DLA.

### <u>Methods + realisation time:</u>

The analytical methods are optional. There is a 6 weeks period for performing the analysis. The results are transmitted by e-mail via the provided results file.

## **Evaluation report:**

The **evaluation** is carried out **strictly qualitatively** (positive/negative) with indication of the obtained agreements with the consensus values of the participants and the spiking of the test areas.

All results including quantitative results, limits of detection and/or quantification and remarks to the methods will be documented. DLA intends to finish the evaluation report within 6 weeks after deadline of results submission.

Each participant receives an anonymized, complete evaluation report as a PDF-file, identifying the own results by individual code in case payment was done and can object in writing to the evaluation within 6 weeks.
