# DLA ptAUS01 - Animal Species-Screening I – 4 Samples qualitative: Rabbit, Deer, Pork, Sheep and Goat in Meat Product (Beef) (Sausage Meat)

### Test material\*:

There are 4 different samples possibly containing the allergenic parameters Rabbit, Deer, Pork, Sheep and Goat for qualitative determination. The parameters are contained in the matrix of heated meat product (beef base) with amounts of 1 - 10%. Sample weight: 4 samples 30 g each.

\* Note: Control of mixture homogeneity and qualitative testings are carried out by DLA. Any testing of the content, homogeneity and stability of PT parameters is subcontracted by DLA.

# **Methods + realisation time:**

Analytical methods for determination are optional. There is a 6 weeks period for performing the analysis. The results are transmitted by e-mail via the provided results file.

## **Evaluation report:**

The **evaluation** is carried out **strictly qualitatively** (positive/negative) with indication of the obtained agreements with the consensus values of the participants and the spiking of samples 1-4.

All results including quantitative results, limits of detection and/or quantification and remarks to the methods will be documented. DLA intends to finish the evaluation report within 6 weeks after deadline of results submission.

Each participant receives an anonymized, complete evaluation report as a PDF-file, identifying the own results by individual code in case payment was done and can object in writing to the evaluation within 6 weeks.
