Terms of the proficiency test (PT)

DLA ptAUS4 (2020) - Fish-Screening – 4 Samples qualitative: Black halibut (*Reinhardtius hippoglossoides*), Atlantic salmon (*Salmo salar*), saithe (*Pollachius virens*) and trout (*Salmo trutta*) in Fish Product (freeze-dried, one species per sample)

Test material* :

There are **4 different samples** possibly containing the allergenic **parameters Black halibut** (*Reinhardtius hippoglossoides*), Atlantic salmon (*Salmo salar*), saithe (*Pollachius virens*) and/or trout (*Salmo trutta*) for qualitative determination. The parameters are in the fish product matrix. There is no more than one fish species per sample. Sample weight: 4 samples 25 g each.

* <u>Note:</u> Control of mixture homogeneity and qualitative testings are carried out by DLA. Any testing of the content, homogeneity and stability of PT parameters is subcontracted by DLA.

Methods + realisation time:

Analytical methods for quantitative determinations are optional.

There is a 10 weeks period (extended deadline) for performing the analysis. The results are transmitted by e-mail via the provided results file.

Evaluation report:

The **evaluation** is carried out **strictly qualitatively** (positive/negative) with indication of the obtained agreements with the consensus values of the participants and the spiking of samples 1-4.

All results including quantitative results, limits of detection and/or quantification and remarks to the methods will be documented. DLA intends to finish the evaluation report within 6 weeks after deadline of results submission.

Each participant receives an anonymized, complete evaluation report as a PDF-file, identifying the own results by individual code in case payment was done and can object in writing to the evaluation within 6 weeks.

Registration :

The reliable order can be sent to DLA or our authorized sales partner.

Shipment + number of participants:

Required minimum number of participants is 10. The samples will be sent to participants in the **week 22** by package service with tracking (delivery time 2-5 days within Europe, 2-10 days worldwide).

Deadline of result submission:

Last date for submission of results **07th August 2020.**

Invoice + price :

Invoicing will be done by DLA along with the sample shipment or by our authorized partner in parallel to the sample shipment.

The price of the proficiency test is $350, -- \in \text{per}$ participant plus shipping and possible tax.

Costs for **double sample material** \in 85,00.
