Terms of the proficiency test (PT)

DLA ptSU06 - Dietetic-Product I: Vitamins B1, B2, B6, B12, Biotin, Vitamin C, Folic Acid, Niacin and Pantothenic Acid (enriched / low levels)

Test material*:

There are **two identical samples** with the parameters **Vitamins B1, B2, B6, B12, Biotin, Vitamin C, Folic Acid, Niacin** and **Pantothenic Acid** to be determined. The matrix is a dietetic food as a meal replacement (drink powder). The contents are in the range of the nutrient reference values per recommended daily dose of approx. 25 g.

Sample weight: 2 Samples 50 g each.

* Note: Control of mixture homogeneity and qualitative testings are carried out by DLA. Any testing of the content, homogeneity and stability of PT parameters is subcontracted by DLA.

Methods + realisation time:

Analytical methods for quantitative determinations are optional.

There is a 6 weeks period for performing the analysis. The results are transmitted by e-mail via the provided results file.

Evaluation report:

The **evaluation** is carried out from a total of 7 results on **quantitatively**. It includes kernel density estimation, outlier tests, robust mean, robust standard deviation and z-scores. The assigned value is the robust mean of participants results. Results, limits of detection and/or quantification and remarks to the methods will be documented. DLA intends to finish the evaluation report within 6 weeks after deadline of results submission.

Each participant receives an anonymized, complete evaluation report as a PDF-file, identifying the own results by individual code in case payment was done and can object in writing to the evaluation within 6 weeks.

Registration:

Shipment + number of participants:

Required minimum number of participants is 10. The samples will be sent to participants in the **week 15** by parcel service with tracking (delivery time 2-5 days within Europe, 2-10 days worldwide).

Last date for submission of results 22nd May 2020.

Invoice + price :

Invoicing will be done by DLA along with the sample shipment or by our authorized partner in parallel to the sample shipment.

The price of the proficiency test is 320,-- € per participant plus shipping and possible tax.
