Terms of the proficiency test (PT)

DLA ptAU11 (2024) - Vegan Compliance Check – 2 Samples qualitative: Animal ingredients in Vegan Burger Powder

Test material* :

Two different samples (positive sample and negative sample) with possible contents of animal components are provided for qualitative determination. The positive sample contains at least two animal components > 0.1% (e.g. egg, fish, meat/gelatine, milk components and/or honey). The parameters are present in the matrix of vegan burger powder. **Sample weight:** 2 Samples 50 g each.

* <u>Note:</u> Control of mixture homogeneity and qualitative testings are carried out by DLA. Any testing of the content, homogeneity and stability of PT parameters is subcontracted by DLA.

Methods + realisation time:

Analytical methods for quantitative determinations are optional.

There is a 6 weeks period for performing the analysis. The results are transmitted online via our customer portal.

Evaluation report:

The evaluation is carried out strictly qualitatively (positive/negative) with indication of the obtained agreements with the consensus values of the participants and the spiking of samples A and B.

All results including quantitative results, limits of detection and/or quantification and remarks to the methods will be documented. DLA intends to finish the evaluation report within 6 weeks after deadline of results submission.

Each participant receives an anonymized, complete evaluation report as a PDF-file, identifying the own results by individual code in case payment was done and can object in writing to the evaluation within 6 weeks.

Registration :

Shipment + number of participants:

Required minimum number of participants is 10. The samples will be sent to participants in the **week 38** by parcel service with tracking (delivery time 2-5 days within Europe, 2-10 days worldwide).

Deadline of result submission:

Last date for submission of results **November 01**st **2024.**

Invoice + price :

Invoicing will be done by DLA along with the sample shipment or by our authorized partner in parallel to the sample shipment.

The price of the proficiency test is $350,- \in$ per participant plus shipping and possible tax.
