Terms of the proficiency test (PT)

DLA ptAL10 (2025) Allergens X: Gluten (Wheat) from Durum Wheat in high-protein Lentil Pasta [Samples A + B] and "Spiking Level Sample" [SP]

Test material* :

There are **two different samples A and B** possibly containing the allergenic **parameter Gluten (Wheat) from Durum Wheat** in the range of mg/kg in the **matrix high-protein Lentil Pasta**. One of these samples and the additional **"spiking level sample"** were prepared adding the allergenic ingredient. The positive food matrix sample is processed with the **incurred** parameter into the pasta dough and then air-dried at approx. 80°C.

The "spiking level sample" contains the allergens in a **simple matrix** (potato powder) in similar amounts without further processing.

Sample weight: Sample A and B 25 g each, and spiking level sample 15 g.

* <u>Note:</u> Control of mixture homogeneity and qualitative testings are carried out by DLA. Any testing of the content, homogeneity and stability of PT parameters is subcontracted by DLA.

Methods + realisation time:

Analytical methods for qualitative and quantitative determinations are optional (e.g. ELISA, LFD, PCR and LC-MS).

There is a 6 weeks period for performing the analysis. The results are transmitted online via our customer portal.

Evaluation report:

The **evaluation** is carried out **qualitatively** (positive/negative) and from a total of 5 results on **quantitatively**. It includes kernel density estimation, outlier tests, robust mean, robust standard deviation and z-scores. The assigned value is the robust mean of participants results. For information a **recovery rate** of the "positive" sample and the "spiking level sample" is calculated including z-scores. Results, limits of detection and/or quantification and remarks to the methods will be documented. DLA intends to finish the evaluation report within 6 weeks after deadline of results submission.

Each participant receives an anonymized, complete evaluation report as a PDF-file, identifying the own

results by individual code in case payment was done and can object in writing to the evaluation within 6 weeks.

Registration :

Shipment + number of participants:

Required minimum number of participants is 10. The samples will be sent to participants on **2025-05-14.** by parcel service with tracking (delivery time 2-5 days within Europe, 2-10 days worldwide).

Deadline of result submission:

Last date for submission of results 2025-06-27.

Invoice + price :

Invoicing will be done by DLA along with the sample shipment or by our authorized partner in parallel to the sample shipment.

The price of the proficiency test is $315, - \in$ per participant plus shipping and possible tax.

Costs for **double sample material** € 90,00.
